on a Community position within the EU-Chile Association Committee on the establishment of a list of arbitrators as required by Article 185 paragraph 2 of the Agreement establishing an association between the European Community and its Member States, of the one part, and the Republic of Chile, of the other part

## **EXPLANATORY MEMORANDUM**

The EU/Chile Association Agreement ("The Agreement") includes in its Part IV, Title VIII a bilateral Dispute Settlement mechanism. Pursuant to Article 185 paragraph 2 of the Agreement, the Association Committee shall establish a list of individuals ready to serve as arbitrators in the bilateral dispute settlement procedures. The Commission and the Chilean government have agreed on a list of fifteen individuals willing and able to serve as arbitrators. As envisaged by the Agreement, this list is composed by five EU nationals, five Chilean nationals and five third country nationals. The EU-Chile Association Committee should now formally adopt this list.

Furthermore, in order to facilitate the task of ensuring that the list always contains fifteen individuals at any point of time, it is proposed that any updating of this list in the future is adopted upon joint written notification by the Parties to the Association Committee, once the Parties have reached an agreement. The Commission shall agree with the Chilean Government on the new list and consult the 133 Committee before the list is notified to Association Committee.

The Commission therefore proposes to the Council to adopt the enclosed Council Decision as the EU common position on the proposed EU-Chile Association Committee Decision in Annex.

## THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Community, and in particular Articles 133 and 300 (2) second subparagraph thereof,

Having regard to the proposal from the Commission<sup>1</sup>,

## Whereas:

- (1) The Agreement establishing an association between the European Community and its Member States, on the one part, and the Republic of Chile, on the other part, thereinafter the Association Agreement includes in its Part IV, Title VIII a dispute settlement mechanism.
- (2) Article 185(2) of the Association Agreement invites the Association Committee, no later than six months after the entry into force of the Agreement, to establish a list of at least fifteen individuals who are willing and able to serve as arbitrators.
- (3) A list of fifteen arbitrators has been agreed by the Parties.
- (4) According to Article 185(2), the Association Committee shall ensure that the list always contains 15 individuals at any point in time. Such list may be amended every three years.
- (5) In order to facilitate the update of the list of arbitrators, a lighter procedure based on a written notification to the Association Committee should be envisaged,

## HAS DECIDED AS FOLLOWS:

## Article 1

The position to be adopted by the Community within the Association Committee on the on the establishment of a list of arbitrators as required by Article 185 paragraph 2 of the Agreement establishing an association between the European Community and its Member States, of the

one part, and the Republic of Chile, of the other part, shall be based on the draft Decision of the Association Committee annexed to this Decision.

## Article 2

For any future updates of the list of arbitrators adopted on the basis of this Decision of the Association Committee, the Commission will seek an agreement with the Chilean Government. The Commission will consult the 133 Committee of the new list of arbitrators as a result of such agreement. Article 1

## THE ASSOCIATION COUNCIL,

Having regard to the Agreement establishing an association between the European Community and its Member States, of the one part, and the Republic of Chile, of the other part, signed in Brussels on 18 November 2002 (hereinafter referred to as "Association Agreement"), and in particular Article 185(2) thereof,

#### Whereas:

- (1) The Agreement establishing an association between the European Community and its Member States, of the one part, and the Republic of Chile, of the other part, thereinafter the Association Agreement includes in its Part IV, Title VIII a dispute settlement mechanism.
- (2) Article 185 paragraph 2 of the Association Agreement invites the Association Committee, no later than six months after the entry into force of the Agreement, to establish a list of at least fifteen individuals who are willing and able to serve as arbitrators, a third of whom must not be national of either Party and are identified as chairperson of arbitration panels.
- (3) A list of fifteen arbitrators has been agreed by the Parties.
- (4) According to Article 185 paragraph 2, the Association Committee shall ensure that the list always contains fifteen individuals at any point of time. Such list may be amended every three years.
- (5) In order to facilitate any future modification of the list of arbitrators, the Parties shall notify in written their mutual agreement in this respect to the Association Committee,

## HAS DECIDED AS FOLLOWS:

## Article 1

The list of fifteen arbitrators annexed to this Decision, is adopted by the Parties.

## Article 2

The list annexed to this Decision should include 15 arbitrators at any in time. For this purpose, this list shall be updated by mutual agreement between the Parties and simple written notification to the Association Committee.

Article 3

This Decision shall enter into force on the day of its adoption.
