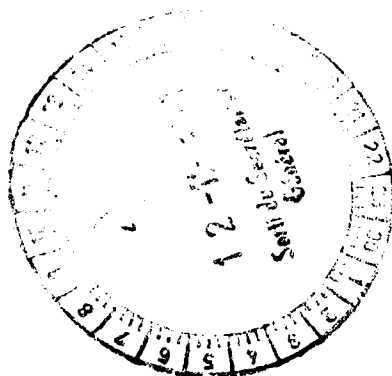

adjusting the subsistence allowance rates for officials on mission

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing a Single Council and a  
Single Commission of the European Communities,

Having regard to the Staff Regulations of Officials of the European  
Communities and the Conditions of Other Servants of the Communities,  
as laid down in Regulation (EEC, Euratom, ECSC) No 259/68<sup>1</sup>, as last  
amended by Regulation (Euratom, ECSC, EEC) No 3085/78<sup>2</sup>, and in  
particular Article 13(10) of Annex VII to the Staff Regulations  
and Articles 22 and 67 of the Conditions of Employment,

Having regard to the proposal from the Commission,

Whereas in view of the increased costs recorded in Denmark,  
the Federal Republic of Germany, Ireland, Italy, the Netherlands and  
the United Kingdom, the rates of daily subsistence allowance for  
officials on mission should be adjusted,

HAS ADOPTED THIS REGULATION:

Article 1

With effect from 1 October 1979, the rates of increase laid down in Article 13 of Annex VII to the Staff Regulations shall be replaced by the following:

- (a) in paragraph 9(a), the rate for missions to Denmark shall be 69%, to the Federal Republic of Germany and to the Netherlands 40%, to Ireland 28%, to the United Kingdom 16% and to Italy 5%;
- (b) in paragraph 9(b), the rate for missions to the Netherlands and to the United Kingdom shall be 59%, to the Federal Republic of Germany and to Denmark 52%, to Italy 44% and to Ireland 21%;
- (c) in paragraph 9(c), the rate for missions to the Federal Republic of Germany shall be 94%, to the United Kingdom 72%, to the Netherlands 61%, to Italy 51% and to Denmark and to Ireland 40%.

Article 2

This Regulation shall enter into force on the day following that of its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
