adjusting the weighting applied to the remuneration and pensions of officials and other servants of the European Communities employed in Italy

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing a Single Council and a Single Commission of the European Communities,

Having regard to the Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Communities laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68¹, as last amended by Council Regulation (ECSC, EEC Euratom) No 1592/76², and in particular Articles 64, 65(2) and 82 of the Staff Regulations and the first paragraph of Article 20 and Article 64 of the Conditions of Employment,

Having regard to the proposal from the Commission,

Whereas, by reason of the substantial rise in the cost of living which took place in Italy during the first quarter of 1976, the weighting applied to the remuneration and pensions of officials and other servants employed there should be adjusted,

HAD ADOPTED THIS REGULATION:

Article 1

1. With effect from 1 April 1976 the weighting applicable to the remuneration of officials employed in Italy shall be 185.2.
2. With effect from 1 April 1976 the weighting applicable to pensions in accordance with the second subparagraph of Article 82(1) of the Staff Regulations shall be 185.2 for persons entitled to pension who declare their homes to be in Italy.

Article 2

The words and figures "Italy 176.6" in both paragraphs of Article 2 of Council Regulation (ECSC, EEC, Euratom) No 1592/76 are repealed with effect from 1 April 1976.

Article 3

This Regulation shall enter into force on the day following its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
