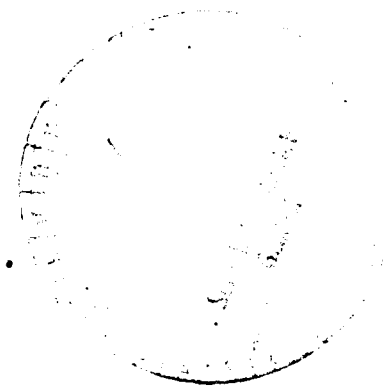

Further to its Communication to the Council of the 23rd November 1978(1), the Commission is submitting for examination by the Council the annexed TAC figures relating to stocks which, on the basis of the results of the consultations held in the context of the reciprocal fishing agreements negotiated by the Community with non-member countries and following a further examination, could be envisaged for certain fish stocks occurring within the Community fisheries zone.
