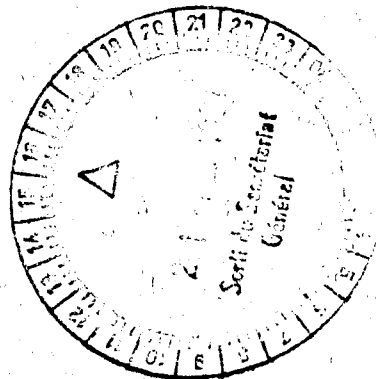

EXPLANATORY MEMORANDUM

1. In consequence of the implementation of the bindings offered by the Community in the course of the Tokyo Round negotiations, the nomenclature of the Common Customs Tariff has been amended. The amendments affect two tariff headings contained in the Agreements with the EFTA States. The Community has also autonomously replaced the European unit of account by the ECU in the Common Customs Tariff.
2. In the light of the above and on the basis of Article 12a of the EEC-Austria Agreement, at the meeting of the EEC-Austria Joint Committee in December 1980 the Austrian Delegation asked for the EEC-Austria Agreement to be updated by the inclusion of the amendments referred to above.
3. These proposals for draft decisions of the Joint Committees meet the Austrian request and also harmonize the tariff situation of the EEC-EFTA Agreements by making the same adjustments in the other Agreements in which there is an Article 12a (13a for Portugal) (1), identical to the one in the EEC-Austria Agreement, empowering established Joint Committees to adjust the nomenclature of the Agreements in the event of amendments to the customs tariff of one or both parties.
