Under a co-operation agreement dated 14 May 1981 between Neunkircher Eisenwerk AG (NE) - a subsidiary of Röchling-Burbach GmbH, which in turn belongs to the Arbed group - and Industrie-Werke Karlsruhe Augsburg AG, IWKA Stahlflaschen GmbH was established with a view to setting up a production shop for high pressure gas cylinders and pressure tanks at NE's Homburg works. The project will create 277 secure jobs in Homburg and make a substantial contribution to the development of steel processing in the Saarland.

To finance the project, Röchling-Burbach GmbH has earmarked guaranteen credits which it will make available to IWKA Stahlflaschen GmbH in agreement with the guarantors as proprietor's loans. Since the acceptance of of asso-С tter has С t bH, the f mbH.

Description

: The aim of the project is to open a new production shop at the Homburg works of Neunkircher Eisenwerk AG. The plant will be installed in workshops vacated as a result of the shutdown of seamless tube production and on which IWKA Stahlflaschen GmbH has taken a long lease.

The ECSC industry has been an important source of employment in the area.

IV. CONFORMITY WITH ARTICLE 56 OF THE ECSC TREATY

ECSC redundancies in project area for the restructuring programme, which provides for the technical and financial amalgamation of the Röchling-Burbach GmbH and Neunkircher Eisenwerk AG steel works, the construction of a new steel works in Völklingen and the shutdown of the liquid phase at Neunkirchen, involves about 8.700 redundancies between 1978 and 1983.

Jobs to be created by the project : 277 permanent jobs will be created as a result of the setting up of the steel cylinder manufacturing plant at Homburg. The jobs will all be offered to ECSC workers made redundant by Neunkircher Eisenwerk AG.

Training

: An internal retraining programme and selective job training of the work-force in the new product range have already begun.

The Commission considers that the application complies with Article 56 (2a) of the ECSC Treaty and that the new jobs to be created by the project are capable of absorbing redundant ECSC workers into productive employment.

V. CONVERSION LOAN

Loan applied for

: DM 13.5 million

: The Commission has approved a loan of DM 13.5 million(about 5.65 MioECU) or equivalent to the above mentioned company in accordance with Article 56 application criteria (OJ C 82, 29 March 1979)
