I. THE COMPANY

Registered Office : Le Chesnay (yvelines), France

Parent company of applicant : Uni-Cardan A.G. (F.R.G.)

Recipient : Uni-Cardan France (UCF) S.A.

Field of activity of recipient : Manufacture of homokinetic cardan couplings and transmission for motor vehicle, industry and public works.

II. THE PROJECT

Description

: The project is to build a factory at Florange (Moselle) to produce homokinetic cardan couplings for motor vehicle, industry and public works. Uni-Cardan France (UCF), S.A. is providing the site and will construct the buildings planned to house the machinery and technical equipment; this material will be financed by Glaenzer & Spicer(*) (another branch of the Group). The products will be manufactured by the Société des Ateliers de Florange (SAF), also a branch of Uni-Cardan France while Glaenzer and Spicer will be sole distributors.

The sectoral and competition aspects of the project have been closely examined ; they do not militate against the granting of the loan applied for.

The project appears to be economically sound ; it will make a significant contribution to the redevelopment of the region which is suffering the effects of a decline in ECSC industries.

: Training to be carried out by the Group, the Regional Employment Office and by AFOREST (Association de Formation des Industries Extractives Sidérurgiques et de Transformation - Training Association for Steel Mining (iron ore) and Processing Industries) at Metz.

The Commission considers that the application complies with Article 56 (2a) of the ECSC Treaty and that the new jobs to be created by the project are capable of absorbing redundant ECSC workers into productive employment.

V. CONVERSION LOAN

: FF 30 million

Loan to be granted

: The Commission has approved a loan of FF 30 million (about 4.52 MioECU) or equivalent to the above mentioned company in accordance with Article 56 application criteria (OJ C 82, 29 March 1979)

Interest rebate

: 3 percentage points per year for five years on 4.52 MioECU.

Job basis of interest rebate

: 226 jobs suitable for former ECSC industry workers, to whom they will be offered in priority.
