I. THE PROJECT

Description

: The products of the new aluminium foundry pressurized and located in Lorraine, on the Villers-la-Montagne site are intended for the exclusive use of motor vehicle companies cooperative production groups of the Groupe Peugeot SA and the Régie Nationale des Usines Renault and its dependent companies. The new investments, as and when realised and in some cases, subject to vocational training, will absorb part of redundant labour in Lorraine.

: The investments will be carried out between 1983 - 1987

Market

: The SFME customers will be exclusively the motor vehicle companies and cooperative production groups of the Groupe Peugeot SA (Automobiles Peugeot, Automobiles Citroen, Société Mécanique Automobile de l'Est, Société Mécanique Automobile du Nord) and the Régie Nationale des Usines Renault and its dependent companies (branches).

Environment

: Environmental protection measures in accordance with current legislation

The sectoral and competition aspects of the project have been closely examined ; they do not militate against the granting of the loan applied for.

The project appears to be economically sound ; it will make a significant contribution to the redevelopment of the region which is suffering the effects of a decline in ECSC industries.

Project location : Villers-la-Montagne, Meurthe-et-Moselle,  
Lorraine (industrial area to the east of

years on 7.52 MioECU.
