II. RECIPIENTS
=====

: Banque Bruxelles Lambert will on lend the global loan funds to small businesses setting up new operations and creating new jobs.

Field of Activity of recipients

: Industrial and service operations.

III. THE PROJECT

Procedure

: The Commission will make BFR 1 000 million available to Banque Bruxelles Lambert, S.A. This decision will be put into effect by concluding a framework agreement: this will be implemented in successive tranches. Sub-loans will be approved by Commission departments.

The Banque Bruxelles Lambert will send the Commission an annual report on the use made of the funds borrowed. The Bank will also send the Commission each year a report on the jobs created, the jobs filled and the number of former ECSC workers re-employed.

Total amount of investment

: at least BFR 2 000 million (+ 44.30 MioECU)

IV. THE REGION

Project location

: Coal and steel areas experiencing heavy redundancies.

Unemployment rate

: At least 12 %.

National aid status of project area

: Development areas.

The ECSC industry has been and still is a major employer in the area.

VI. GLOBAL LOAN

Loan applied for : BFR 1 000 million (about 22.15 MioECU)

Loan to be granted : The Commission has approved a loan of BFR 1 000 million (about 22.15 MioECU) or equivalent to the above mentioned institution in accordance with Art. 56 application criteria (OJ C 82, 29 March 1979).

Interest rebate : 5 percentage points per year for five years on 22.15 MioECU

Job basis of interest rebate : 1 107 jobs suitable for former ECSC workers, to whom they will be offered in priority.
