

REPORT TO THE COUNCIL

In accordance with the provisions of Article 99 of the Staff Regulations, the appointing authority has granted, for 1981, bonuses for exceptional service to certain officials and temporary staff who occupy a post in the field of nuclear science calling for scientific or technical qualifications and who are paid from research and investment appropriations. The bonus unit is Bfrs 50 000.

The recipients have been selected on the following criteria:

- (a) outstanding work, usually published (excluding patented and exploited inventions, which are covered by Article 94 of the Staff Regulations);
- (b) special performance (sustained efforts in connection with experiments and warious studies);
- (c) special behaviour under particular circumstances (industrial accident, fire, contamination).

The figures in the three tables attached specify:

Annex I

The amount, total number and number by grade of recipient of the bonuses awarded, giving a breakdown by establishment and department.

Anner II

- 1. The amount of the bonuses paid out, compared with basic salaries paid in 1981.
- 2. The number of officials and temporary staff classed as scientific or technical staff at 31 May 1981 and the number of officials and temporary staff who have received bonuses.
- 3. The above two items expressed as percentages.

Annex III

Number of recipients of bonuses, by category and selection criterion.

The Commission draws particular attention to the fact that it has kept within the limits fixed in the Staff Regulations for the aggregate amount and for the individual amount of the bonuses awarded. The regulation limit for the aggregate amount is 3% of total basic salaries paid to scientific and technical staff, and the actual figure for 1981 is 0.1762%; the limit for the individual amount is three times the amount of the basic monthly salary.

STATISTICS

1. The basic salaries paid to scientific and technical staff for 1981 amounted to approximately Bfrs 2 695 226 594.

The bonuses awarded for exceptional services totalled Bfrs 4 750 000 (budget allocation: Bfrs 6 325 147).

- 2. 1 997 officials and temporary staff were classed as scientific or technical staff on 31 May 1981.
 - 90 bonuses were awarded (of which five were two-unit bonuses):
 - 49 to officials
 - 41 to temporary staff.
- 3. The above figures show that:
 - 4.51% of the staff were awarded the exceptional-service bonus, the bonuses awarded represent 0.1762% of the total basic salaries paid during the year.
