EXPLANATORY MEMORANDUM

In accordance with Article 2 of the Council Directive on mountain and hill farming and farming in certain less favoured areas, the

Government has proposed to inscribe certain small areas affected by specific handicaps in the Community list of less favoured areas within the meaning of Directive 75/268.

On the basis of the Commission proposal the Council established through Directive 75/275/EEC the Community list of less favoured agricultural areas. It has become evident meantime that a certain number of the areas included in the annex to Directive 75/275, have been withdrawn from agriculture for reasons of nature conservation.

By reason of this change, it is no longer necessary that these areas remain on the Community list.

On the other hand, the Government has requested the inscription in the Community list of other areas affected by the same specific handicaps which correspond to the characteristics specified for the designation of the zones appearing in the Community list established in 1975.

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Directive 75/268/EEC of 28 April 1975 on mountain and hill farming and farming in certain less-favoured areas<sup>1</sup>, as last amended by Directive 80/666/EEC<sup>2</sup>, and in particular Article 2(3) thereof,

Having regard to the proposal from the Commission,

Having regard to the opinion of the European Parliament,

Whereas Council Directive 75/275/EEC of 28 April 1975 concerning the Community List of less-favoured farming areas within the meaning of Directive 75/268/EEC (Netherlands)<sup>3</sup> indicates the areas in the Netherlands included in the Community List of less-favoured areas within the meaning of Article 3(5) of Directive 75/268/EEC;

Whereas the Netherlands Government has applied, under Article 2(1) of Directive 75/268/EEC, to have the list of areas contained in the Annex to Directive 75/275/EEC amended in accordance with the Annex to this Directive;

Whereas the new areas contained in the list correspond to the criteria and values which were applied in Directive 75/275/EEC for determining the areas concerned within the meaning of Article 3(5) of Directive 75/268/EEC;

Whereas moreover the total surface area of these areas is less than 2.5% of the total surface area of the Netherlands;
