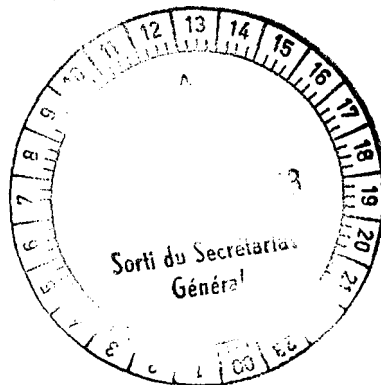

EXPLANATORY MEMORANDUM

Regulation (EEC) No 2915/79, in Annex II (c), first indent under (b), provides for an annual tariff quota for Emmentaler, Gruyère, Sbrinz and Bergkäse from Finland of 2 950 tonnes.

On 11 May 1983, Finland and the Community agreed to increase, for 1983, the quantities laid down in the temporary arrangement for a concerted discipline concerning reciprocal trade in cheese.

In order that the Community can fulfil its undertakings as regards the amount of the Emmentaler quota for 1983, a temporary derogation must be made from the quantity limits currently valid.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 804/68 of 27 June 1968 on the common organization of the market in milk and milk products¹, as last amended by Regulation (EEC) no 1600/83², and in particular Article 14(6) thereof,

Having regard to the proposal from the Commission,

Whereas Council Regulation (EEC) No 2915/79 of 18 December 1979 determining the groups of products and the special provisions for calculating levies on milk and milk products and amending Regulation (EEC) No 950/68 on the Common Customs Tariff³, as last amended by Regulation (EEC) No 1206/83⁴, provides under (b) in the first indent of Annex II (c) for an annual tariff quota of 2 950 tonnes for Emmentaler, Gruyère, Sbrinz and Bergkäse cheeses from Finland; whereas Finland and the Community have agreed to increase the quota for 1983 with the aim of developing reciprocal trade; whereas, to enable the Community to fulfil the undertakings it has made, derogations should be made from the provisions governing the annual tariff quotas allotted to Finland in respect of the said cheeses,

HAS ADOPTED THIS REGULATION:

Article 1

for 1983, notwithstanding Annex II (c) to Regulation (EEC) No 2915/79, the quantity of 2 950 tonnes of products originating in Finland appearing in the first indent under (b) is hereby replaced by 3 250 tonnes.

Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
