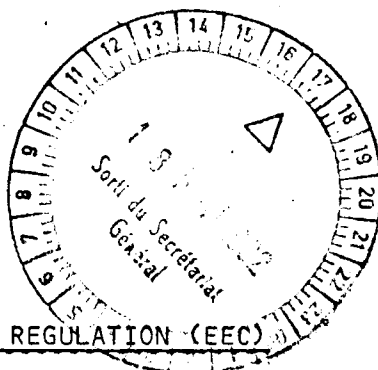

DRAFT COUNCIL REGULATION (EEC)

temporarily suspending the autonomous Common Customs Tariff
duties on a number of agricultural products

(submitted to the Council by the Commission)

EXPLANATORY MEMORANDUM

1. The subject of the following draft regulation is the temporary suspension of duties in the Common Customs Tariff for a number of agricultural items, as requested by the Member State.

It is partly a prolongation and partly a new measure.

2. It seems appropriate to the Commission that a duty suspension is justified for the goods listed in the annex to this regulation.

The Commission proposes a total suspension for those products for which Community production does not exist or is minimal.

A partial suspension is proposed in cases where the Community production covers only a part of the requirements and where the abolition of the duty protection does not jeopardize the market for that production. The rate of the

partially suspended duty depends on the extent of the possible Community supply to the Community users. The Commission is also looking for the right balance between the interests of the suppliers, users and the consumers in the Community.

It also takes into account the need to protect employment.

3. The proposed measures are confined to a fixed period because of the difficulties of estimating the evolution of the basic factors.
4. For a number of items for which the Member States also requested duty suspensions the Commission does not propose a tariff measure:

a) 03.01 A I b) Salmon, fresh (live or dead), chilled or frozen

The Commission's opinion is that because of Irish and United Kingdom production, the duty suspension requested by France, Germany and Denmark, is not appropriate.

It should be furthermore noted that as the present CCT duty rate is only 3.3% it is questionable whether a duty suspension would have a significant impact on the price of the finished product.

- b) ex 03.01 B I h) Cod (*Gadus morrhua* or *Gadus callarias*), fresh, chilled, whole, intended for processing
- ex 03.01 B I k) Haddock, fresh, chilled, whole, intended for processing
- ex 03.01 B I q) Hake (*Merluccius* spp) fresh, chilled, whole, intended for processing
- ex 03.01 B II a) Fillets of hake (*Merluccius* spp), fresh, chilled and B II b) 7 or frozen, intended for processing

The duty suspensions requested by Denmark, for the abovementioned white fish do not seem justified, because landings from Norway and East European countries, at relatively low prices, have caused difficulties throughout the Community market.

The Commission believes that the problems experienced by Danish processors could be alleviated by better contacts with Community catchers (particularly Ireland and the United Kingdom) and, furthermore, Denmark has the possibility to benefit from a reduced rate of 3.7% for Icelandic cod and haddock.

- c) ex 03.03 A I Tails of crawfish, chilled or frozen, shelled or not

The Commission cannot accept that subsidises in form of a duty suspension (as requested by France and the United Kingdom) should be granted for these luxury goods which unlike in usual cases of duty suspension are not intended to improve the competitiveness of Community processors, but are sold direct to the consumer.

- d) ex 16.04 C II Spiced and salted herrings, in immediate packings of a net capacity of 10 kg or more of which the average weight of 7 headless herrings is greater than 1 kg

The sensitivity of the Community herring market is such that the requested duty suspension (Denmark) does not seem justified. There exists a duty reduction to 10% for this type of herring from Iceland and there are in addition measures for herring and other semi-finished herrings products erga omnes.

5. Attention is drawn to the fact that the Council Resolution of 27.6.1974 simplifying the task of the customs administrations (OJ C 79/74) requires the publication of the attached Regulation at least six weeks before this entry into force.

THE COUNCIL OF THE EUROPEAN
COMMUNITIES,

Having regard to the Treaty establishing the European
Economic Community, and in particular Article 28
thereof,

Having regard to the draft Regulation submitted by
the Commission,

Whereas production in the Community of the
products specified in this Regulation is currently
inadequate or non-existent; whereas producers thus
cannot meet the needs of user industries in the
Community;

Whereas in certain cases it is in the interest of the
Community to suspend the autonomous Common
Customs Tariff duties only partially, particularly since
the goods in question are produced in the Community
and in the other cases to suspend them totally;

Whereas, in view of the difficulty of assessing accu-
rately short-term trends in the economic situation in
the relevant sectors, suspension measures should be

taken only temporarily by fixing their period of vali-
dity by reference to the interests of Community
production,

HAS ADOPTED THIS REGULATION:

Article 1

The autonomous Common Customs Tariff duties for
the products listed in the tables annexed hereto shall
be suspended at the level indicated against each of
them.

These suspensions shall be applicable:

- from 1 July to 31 December 1982 for
the products listed in Table I,
- from 1 July 1982 to 30 June 1983 for the
products listed in Table II.

Article 2

This Regulation shall enter into force on 1 July 1982.

This Regulation shall be binding in its entirety and directly applicable in all Member
States.

(a) Checks on their use for this special purpose shall be carried out pursuant to the relevant Community provisions.

(b) The suspension shall apply to fish intended to undergo any operation unless they are intended to undergo exclusively one or more of the following operations:

- cleaning, gutting, tailing, heading;
- cutting (excluding filleting or cutting of frozen blocks);
- sampling, sorting;
- labelling;
- packing;
- chilling;
- freezing;
- deep freezing;
- thawing, separation.

The suspension is not allowed for products intended, in addition, to undergo treatment (or operations) qualifying for suspension where such treatment (or operations) is (are) carried out at retail or catering level.

The suspension of customs duties shall apply only to fish intended for human consumption.

(c) However, the suspension is not allowed where the treatment is carried out by retail sale or catering undertakings.
