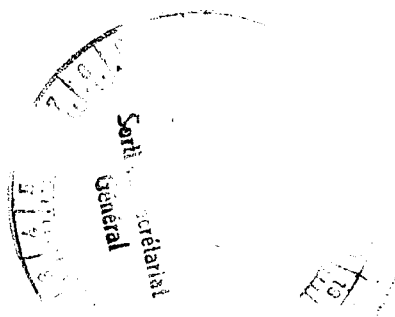

EXPLANATORY MEMORANDUM

In the price proposals for the 1983/84 marketing year, the Commission undertook to put forward rules for a definitive scheme for soya beans harvested in the Community.

On 3 July 1980 the Council adopted, on an experimental basis, Regulation (EEC) No 1724/80 adopting general rules concerning special measures for soya beans harvested in 1980. The general rules were renewed for 1981 and 1982.

Experience gained over the three years has proved the effectiveness of the rules. They should therefore be made permanent.

It should be noted that with effect from the 1982/83 harvest exceptional arrangements were adopted on an experimental basis for soya beans harvested in the French overseas departments. Since these arrangements take account of the specific situation with regard to the production and marketing structure of soya beans in the overseas departments, they should continue to apply until the situation in those areas allows a definitive scheme to be applied.

Since the object of this proposal is simply to prolong the general rules for determining and controlling the measures in question, it has no financial implications.

COUNCIL REGULATION (EEC)

amending Regulation (EEC) No 1724/80 adopting general rules concerning
special measures for soya beans

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 1614/79 of 24 July 1979 laying down special measures in respect of soya beans (1), as amended by Regulation (EEC) No 1984/82 (2), and in particular Article 2(4) thereof,

Having regard to the proposal from the Commission,

Whereas Council Regulation (EEC) No 1724/80 (3), as last amended by Regulation (EEC) No 2549/82 (4), adopted general rules for the aid system for soya beans harvested in 1980, 1981 and 1982;

Whereas experience gained during the period of implementation of the measures has allowed an assessment to be made of the effectiveness thereof; whereas the rules laid down in Regulation (EEC) No 1724/80 should therefore be made definitive;

Whereas Regulation (EEC) No 1984/82 amended Regulation (EEC) No 1614/79 by laying down derogating measures for soya beans harvested in the French overseas departments from the 1982/83 harvest onwards in order to take account of the specific situation with regard to production and marketing structures in those departments; whereas the derogating measures should continue to apply for so long as the specific situation exists,

HAS ADOPTED THIS REGULATION :

Article 1

The second paragraph of Article 8 of Regulation (EEC) No 1724/80 is hereby replaced by the following :

"However, Article 5a shall apply only to beans harvested from the 1982/83 marketing year onwards."

Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
