EXPLANATORY MEMORANDUM

Regulation (EEC) No 2470/78 of 16 October 1978 (1) opened for 1979 for certain plywoods of coniferous species a Community tariff quota which was subject to review in the course of the year. The initial quantity was 700,000 m³.

This review was carried out on 25 June 1979. It emerged from consultation with the Member States that additional requirements will be in the region of 150,000 m³. While awaiting a new revision which will be made in September, on the basis of more precise economic data, it is proposed to settle for a provisional increase of 100,000 m³.

This proposition is intended to introduce the increase, by means of increasing the Community reserve to which all Member States which have used up their initial share have access.

COUNCIL REGULATION (EEC)

increasing the Community tariff quota opened for 1979 by Regulation (EEC) No 2470/78 for certain plywoods of coniferous species falling within heading No ex 44.15 of the Common Customs Tariff

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Articles 28 and 113 thereof,

Having regard to the proposal from the Commission,

Whereas by Regulation (EEC) No 2470/78 (1) the Council opened and allocated among the Member States, for certain plywoods of coniferous species falling within heading No ex 44.15 of the Common Customs Tariff, a Community tariff quota with zero duty, the volume of which was fixed at a level of 700 000 cubic metres;

Whereas, on the basis of the most recent data on these products for 1979, it may be estimated that the additional imports from non-member countries required by the Community could reach 150 000 cubic meters; whereas, pending a new revision made on the basis of more precise economic data, it is necessary to increase the quota by 100 000 cubic metres in order to take into account the said immediate requirements; whereas, in order to safeguard the Community character of the tariff quota in question, the proposed increase should be added to the Community reserve set up under the above-mentioned Regulation,

HAS ADOPTED THIS REGULATION :

Article 1

1. The volume of the Community tariff quota opened by Regulation (EEC) No 2470/78 for certain plywoods of coniferous species falling within heading No ex 44.15 of the Common Customs Tariff is hereby increased from 700 000 to 800 000 cubic metres.

2. This increase of 100,000 cubic metres shall be added to the reserve set up by virtue of Article 2(3) of Regulation (EEC) No 2470/78 which is thus increased from 30.000 to 130.000 cubic metres.

Article 2

This Regulation shall enter into force on the seventh day following its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
