EXPLANATORY MEMORANDUM

The temporary joint discipline arrangements between Norway and the European Economic Community on mutual trade in cheese was to enter into force on 1 January 1983 but because of difficulty in preparing the necessary implementing provisions Norway cannot apply them from 1 January.

The purpose of this proposal is to suspend temporarily the provisions of Regulation (EEC) No 2915/79 on special measures applying to imports of cheese from Norway.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 804/68 of 27 June 1968 on the common organization on the market in milk and milk products (1), as last amended by Regulation (EEC) No 1183/82 (2), and in particular Article 14(6) thereof,

Having regard to the proposal from the Commission,

Whereas Council Regulation No 2915/79 of 18 December 1979 determining the groups of products and the special provisions for calculating levies for milk and milk products and amending Regulation (EEC) No 950/68 on the Common Customs Tariff (3), as last amended by Regulation (EEC) No 304/82 (4), lays down certain conditions for entry into the Community of certain cheeses falling within heading 04.04 of the Common Customs Tariff,

Whereas a temporary arrangement between Norway and the European Economic Community on joint discipline in their trade in cheese has been concluded; whereas difficulties in connection with implementation of these arrangements are preventing Norway from applying them from 1 January 1983; whereas for this reason it is necessary to temporarily suspend application of the arrangement;

HAS ADOPTED THIS REGULATION:

Article 1

Application of Article 11(2) of Regulation (EEC) No 2915/79 is suspended for the product indicated at Annex II(r) of that Regulation.

Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

It shall apply from 1 January 1983.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
