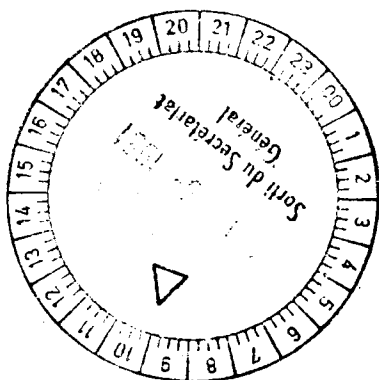

EXPLANATORY MEMORANDUM

Article 22 paragraph 2 of Council Regulation No 136/66/EEC, establishing a common organization of the markets in the oils and fats sector, requires that, every year, before the beginning of the marketing year, the Council fixes the principal intervention centres in the Community and the intervention prices applicable to them for colza, rape and sunflower seeds.

This proposal concerns the fixing of centres and prices for the 1981/82 marketing year.

For colza and rapeseeds, it is proposed to add to the existing intervention centres, those of ODENSE and HADERSLEV in Denmark, GRONINGEN in the Netherlands and CAMBRIDGE and OXFORD in the United Kingdom. These are centres situated in zones where colza production has particularly developed during recent years, notably in the Member States which joined after 1973.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation No 136/66/EEC of 22 September 1966 on the establishment of a common organization of the market in oils and fats⁽¹⁾, as last amended by the Act of Accession of Greece, and in particular the first subparagraph of Article 22 (2) thereof,

Having regard to the proposal from the Commission,

Whereas, in accordance with Article 22(2) of Regulation No 136/66/EEC, the main intervention centres for colza and rape seed and sunflower seed and the derived intervention prices applicable at those centres should be fixed for the 1981/82 marketing year;

Whereas the locations of the principal markets in the main production areas should be adopted as main intervention centres; whereas the locations which are most representative for the processing of these seeds and the locations outside production areas which are representative for internal trade and the export trade in those seeds should also be adopted as main intervention centres;

Whereas, in accordance with Article 2 of Council Regulation (EEC) No 1585/80 (2), the derived intervention prices should be fixed at levels which will allow a smooth transition to the intervention price system to be applied from the 1982/83 marketing year;

Whereas the experience acquired during the 1980/81 marketing year indicates that the main intervention centres fixed for colza and rape seed and sunflower seed for that marketing year should be retained for the 1981/82 marketing year, with the addition of several new centres for colza and rape seed,

HAS ADOPTED THIS REGULATION :

Article 1

For the 1981/82 marketing year, the main intervention centres for colza and rape seed and sunflower seed and the intervention prices applicable in these centres shall be as indicated in the Annex.

Article 2

This Regulation shall enter into force on 1 July 1981 for colza and rape seed and on 1 September 1981 for sunflower seed.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
