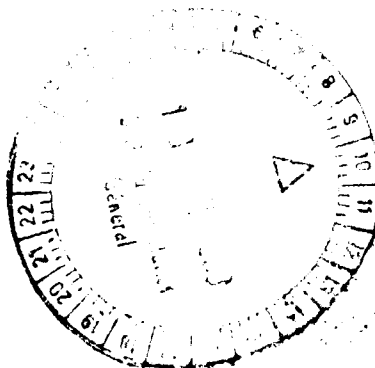

EXPLANATORY MEMORANDUM

1. Directive 79/359/EEC, known as the Charentes Directive, provides for the conversion of 7.500 hectares of vineyard used to produce wine suitable for the production of certain wine spirits with a registered designation of origin.  
Adopted by the Council on 26 March 1979 the Directive expired on 31 August 1982. During the period of its application 4.500 hectares were converted.
2. Council Regulation (EEC) No 456/80 of 18 February 1980 makes provision for temporary and permanent abandonment premiums and premiums for the renunciation of the planting in respect of certain areas under vines. The Charentes region, which comes within the scope of Directive 79/359/EEC, is not eligible under the Regulation.
3. The aim of the attached proposal is to extend Regulation (EEC) No 456/80 to include the Charentes departments.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 43 thereof,

Having regard to the proposal from the Commission<sup>1</sup>,

Having regard to the opinion of the European Parliament<sup>2</sup>,

Having regard to the opinion of the Economic and Social Committee<sup>3</sup>,

Whereas, under the first indent of Article 1(3) of Council Regulation (EEC) No 456/80<sup>4</sup>, areas falling within the scope of Council Directive 79/359/EEC of 26 March 1979 on the programme to speed up the conversion of certain areas under vines in the Charentes departments<sup>5</sup> are not eligible for premiums;

Whereas the common measure initiated by Directive 79/359/EEC ended on 31 August 1982; whereas during the period of application of that Directive it was not possible for technical reasons, especially in the early stages, to complete the planned programme; whereas, in order to enable the conversion operations to be continued, Regulation (EEC) No 456/80 should be amended in order to extend its scope to vineyards in the Charentes departments,

HAS ADOPTED THIS REGULATION:

Article 1

Regulation (EEC) No 456/80 is hereby amended as follows:

1. In Article 1(3) the first indent is deleted.
  
2. In Article 12(1) the sum of 128.8 million European units of account is replaced by 134.3 million European units of account.

Article 2

This Regulation shall enter into force on the day of its publication in the Official Journal of the European Communities.

It shall apply from 1 September 1982.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

 COMMENTS: The table of the five-year appropriations of the EAGGF Guidance Section sent to the Council on 28 July<sup>1982</sup> (COM(82)440) shows estimated total expenditure in respect of Directive 79/359/EEC of 13.3 million ECU for the period 1980-84. On the basis of the latest grubbing-up operations (1981/82) actual reimbursements for the same period are put at 11.7 million ECU. This saving will make it possible to finance the grubbing-up operations under Regulation 456/80 without adjusting the overall utilization of the five-year appropriations.
