EXPLANATORY MEMORANDUM

In order to encourage the national and local authorities to make more use of the school-milk scheme, the Commission considers it would be of some value to extend the minimum period for which the continuation of the Community contribution towards financing the programmes is guaranteed. This proposal guarantees the Community contribution for a period of 5 years from the start of the 1983/84 milk year.

The financial implications of this proposal have already been taken into account in the price proposals.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 804/68 of 27 June 1968 on the common organization of the market in milk and milk products<sup>(1)</sup>, as last amended by Regulation (EEC) No 1183/82<sup>(2)</sup>, and in particular the second subparagraph of Article 26 thereof,

Having regard to the proposal from the Commission,

Whereas Regulation (EEC) No 1080/77<sup>(3)</sup>, as last amended by Regulation (EEC) No 1188/82<sup>(4)</sup>, provides for a Community contribution to the cost of Member States' programmes for the supply of milk and certain milk products at reduced prices to schoolchildren;

Whereas, in order to encourage consumption of milk and milk products in schools, it is advisable to extend the minimum period for which Article 1(1) of Regulation (EEC) No 1080/77 guarantees Community contributions towards financing the programmes in question,

HAS ADOPTED THIS REGULATION:

Article 1

In Article 1(1) of Regulation (EEC) No 1080/77, '1981/82 milk year' is hereby replaced by '1983/84 milk year'.

Article 2

This Regulation shall enter into force on 1 April 1983.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
