

amending Regulation No 115/67/EEC with regard to the criteria for determining the world market price for oil seeds

EXPLANATORY MEMORANDUM

Council Regulation (EEC) No 2917/80 of 11 November 1980 provides for adjustment of the daily aid rate for colza. This measure is applicable until 30 June 1980 and was taken in order to allow for milling of Community colza production, which had increased in 1980.

In the minutes of the 701st meeting of the Council, held from 30 March to 2 April 1981, during which the Council decided on the agricultural prices for 1981/82, the following declaration was entered: "the Council would decide, on a proposal from the Commission, to maintain the provisions for payment of the daily aid rate for colza provided for in Regulation (EEC) No 2917/80, for the 1981/82 marketing year".

This proposal for a regulation accordingly provides for extension to 30 June 1982 of the provisions laid down in Regulation (EEC) No 2917/80.

Proposal for a COUNCIL REGULATION (EEC)

amending Regulation No 115/67/EEC with regard to the criteria for determining the world market price for oil seeds

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation No 136/66/EEC of 22 September 1966 on the establishment of a common organization of the market in oils and fats⁽¹⁾, as last amended by the Act of Accession of Greece, and n particular Article 36 thereof,

Having regard to the proposal from the Commission,

Whereas, under Article 29 of Regulation No 136/66/EEC, when the world market price for oil seeds is being determined, prices shall be adjusted where appropriate to take the prices of competing products into account;

Whereas, owing to the exceptional situation on the market in colza and rape seed for the 1980/81 marketing year, provision was made for an additional adjustment, when the world market price was being determined, to improve the marketing of Community seeds and at the same time make maximum use of crushing capacities; whereas, to this end, Council Regulation No 115/67/EEC⁽²⁾ was amended by Regulation (EEC) No 2917/80⁽³⁾,

Whereas the situation is the same for the 1981/82 marketing year; whereas the said measure should be extended to apply for a further year,

HAS ADOPTED THIS REGULATION :
