

EXPLANATORY MEMORANDUM

"Long eggs", preparations consisting of eggs cooked in the form of cylinders and destined to be cut into slices represent a new transformed egg-based product, and thus could have a certain economic importance in the egg sector. Classified under tariff heading 21.07 G I a) 1, "long eggs" are not subject to the common organization of the market in eggs, but fall under the trade arrangements applicable to certain goods resulting from the processing of agricultural products (goods "outside Annex II").

The Council invited the Commission on the codification of regulations for goods "outside Annex II" at the end of 1980, to present a proposal to introduce a refund system for "long eggs".

Only the egg-based products "outside Annex II", which are contained in Annex I of Council regulation 2771/75 on the common organization of the market in eggs may benefit from export refunds. "Long eggs" are not included at present.

In order to establish a legal base permitting the granting of export refunds, it will be necessary to add "long eggs" to Annex I of the said regulation.

PROPOSAL FOR A
COUNCIL REGULATION (EEC)

amending Regulation (EEC) No 2771/75 on the
common organization of the market in eggs

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular Article 43 thereof,

Having regard to the proposal from the Commission,

Having regard to the Opinion of the European Parliament¹,

Whereas Council Regulation (EEC) No 2771/75²,
as last amended by the Act of Accession of

Greece, laid down that an export refund may be granted on eggs exported in the form of the processed products listed in Annex I thereto;

Whereas new products from hens' eggs have appeared on the market which might be of economic importance for the egg sector; whereas it is desirable to increase those outlets by facilitating the export of eggs in the form of those products; whereas, to that end, Annex I to Regulation (EEC) No 2771/75 should be supplemented so as to enable export refunds to be granted on the eggs contained in those products;

HAS ADOPTED THIS REGULATION:

Article 1

Annex I to Regulation (EEC) No 2771/75 is hereby replaced by the Annex to this Regulation.

Article 2

This Regulation shall enter into force on 1 November 1981.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
