EXPLANATORY MEMORANDUM

Regulation (EEC) No 1362/78 provides for the programme for the acceleration of collective irrigation works in the Mezzogiorno to be implemented over a period of five years from the entry into force of the Regulation.

Drawing up and approving the outline programme took 17 months. Because of this, implementation of the programme began very late.

On the basis of experience gained from applying the first specific programmes, the provision concerning the time allowed for implementing the common measure has been made more flexible in the case of specific programmes adopted from 1981 onwards in that the time allowed is counted from the date on which the programme is approved.

Five year should be allowed for the implementation of this programme.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

**Having regard to the Treaty establishing the European Economic Community,
and in particular Article 43 thereof,**

Having regard to the proposal from the Commission,

Having regard to the opinion of the European Parliament (2),

**Whereas a period of five years was considered necessary for carrying out
the work under the programme;**

**Whereas drawing up the outline programme took longer than expected and
for that reason the programme did not begin to be implemented until
17 months after the entry into force of Regulation (EEC) No 1362/78;**

**Whereas a period of five years should be allowed for implementing the
programme,**

HAS ADOPTED THIS REGULATION :

Article 1

Article 10(1) shall be replaced by the following :

"1. The period envisaged for implementing the common measure shall be five years from the date of approval of the outline programme referred to in Article 2."

Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.
