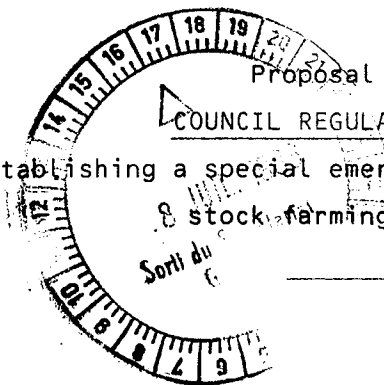

EXPLANATORY MEMORANDUM

1. The implementation of the agricultural structural measures, in particular those directed specifically at farmers, depends largely on the existence of effective agricultural advisory services. Such services are still very much lacking in Greece, however.

The application of the socio-structural Directives in Greece with effect from 1 January 1984, the application of Regulation (EEC) N° 1975/82 but, above all, the application of the various measures to assist the development of agricultural structures contained in the Commission proposals forwarded to the Council on 21 March 1983 make it essential for steps to be taken to establish a system of agricultural advisory services.

The Council, at its meeting on 16 and 17 May, therefore requested the Commission to put forward a proposal to that end.

2. The Community expenditure resulting from the proposed measure is contained within the five-year endowment of the EAGGF Guidance section.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,
and in particular Article 43 thereof,

Whereas the Commission, on 21 March 1983, put forward proposals to the Council concerning, among other things, the future structural development of agriculture in Greece ;

Whereas effective implementation of Community measures for improving agricultural structures in Greece, whether already adopted or to be adopted by the Council in the future, calls for immediate action in the field of agricultural advisory services, which are at present under-developed ;

Whereas the development of a system of agricultural advisory services in Greece is thus of particular Community interest and whereas the relevant measures therefore constitute a common measure within the meaning of Article 6 of Council Regulation (EEC) N° 729/70 of 21 April 1970 on the financing of the common agricultural policy (3) ;

HAS ADOPTED THIS REGULATION :

Article 1

In order to facilitate the start of implementation of Community policy for the improvement of agricultural structures in Greece, a common measure within the meaning of Article 6 of Regulation (EEC) N° 729/70 is hereby introduced for the development of agricultural advisory services in Greece.

Article 2

The common measure may comprise:

- the creation of training centres for agricultural advisors ;
- specialist training of teaching staff ;
- training of agricultural advisors ;
- employment of agricultural advisors ;

Article 3

Greece shall adopt the provisions necessary for the application of the common measure and shall forthwith notify the Commission thereof.

Article 4

1. The duration of the common measure shall be limited to one year with effect from 1 January 1984.
2. The estimated cost of the common measure to the European Agricultural Guidance and Guarantee Fund, Guidance section, shall be 4 million ECU.
3. The Fund shall reimburse 50% of actual expenditure on implementation of the common measure incurred by Greece.

However, the maximum eligible amount for the employment of advisors shall be limited to 12,500 ECU for each newly employed advisor.

4. The grant of aid from the Fund shall be decided on in accordance with Article 7 (1) of Regulation (EEC) N° 729/70.
5. Advances may be granted on application by Greece.
6. Detailed rules for the application of this Article shall be adopted in accordance with the procedure laid down in Article 13 of Regulation (EEC) N° 729/70.

Article 5

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

OBSERVATIONS : Indirect measure - commitment and payment simultaneous. It is unlikely that implementation of the measure would permit payments in 1983. However, as long as uncertainty remains, a token entry should be made in the 1983 budget so that a payment can be made, if necessary, after transfer.

EXPLANATORY MEMORANDUM

1. Under Council Regulation (EEC) N° 1054/81 of 21 April 1981 (1), Ireland and the United Kingdom have been implementing programmes to develop beef cattle production, with particular reference to the genetic improvement of livestock and the quality of the fodder they receive, in order to help redress the current adverse income situation in agriculture in Ireland and Northern Ireland.

Article 4 of the Regulation confines the duration of this "common measure" to two years, ending on 25 May 1983; it also fixes the maximum amounts eligible for reimbursement by the EAGGF Guidance Section in respect of the different schemes involved.

2. During its meeting of 16 and 17 May 1983 the Council called on the Commission to submit a proposal prolonging the application of Regulation (EEC) N° 1054/81 until 30 April 1984 especially for the updated aid for artificial insemination and for the increased use of lime.

The present proposal consequently aims to modify the said Regulation, prolonging the common measure in question, with the exception of the encouragement for silage-making, and increasing the maximum amounts of eligible expenditure for the encouragement of artificial insemination and for the improvement of pastures and meadows through the increased use of lime.

The proposal also includes the insertion in Regulation (EEC) N° 1054/81 of a clause under which, where necessary, the maximum amounts of expenditure in each field can be adjusted against each other without increasing the total maximum amount.

3. The estimated cost of the prolongation for EAGGF (Guidance Section) is 10 MECU.

The additional expenditure arising from this proposal will come under the five-year allocation of the EAGGF Guidance Section.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,
and in particular Articles 42 and 43 thereof,

Having regard to the proposal from the Commission,

Having regard to the opinion of the European Parliament,¹

Whereas, pursuant to Council Regulation (EEC) N° 1054/81
Ireland and the United Kingdom have instituted a programme to develop beef
cattle production, with particular reference to the genetic improvement of
livestock and improvement of the quality of their fodder, with a view to
redressing the current adverse income situation in agriculture in Ireland
and Northern Ireland.

Whereas, under Article 4 of the said Regulation, the duration of this common
measure is limited to a period of two years ending on 25 May 1983 and
maximum amounts are laid down in respect of the expenditure under each
individual scheme which is eligible for reimbursement by the Guidance Section
of the European Agricultural Guidance and Guarantee Fund;

Whereas, in order to consolidate the favourable results obtained so far, the duration of the common measure should be extended to 30 April 1984, with the exception of encouragement of silage-making, and the maximum amounts of eligible expenditure for the encouragement of greater use of artificial insemination and the improvement of pastures and meadows through increased use of lime should be raised;

Whereas provision should also be made for adjusting, where necessary, the maximum amounts of eligible expenditure against each other without increasing the total amount,

HAS ADOPTED THIS REGULATION :

Article 1

Regulation (EEC) N° 1054/81 is hereby amended as follows:

1. Paragraphs (1) and (2) of Article 4 are replaced by the following:

"1. The duration of the common measure shall be limited:

- in respect of the measures referred to in Article 3 (1) (e), to two years commencing on the date on which the Commission adopts the detailed rules referred to in Article 3 (2) and
- in respect of the measures referred to in Article 3 (1) (a), to (d) to 30 April 1984.

2. The expenditure incurred by Ireland, and by the United Kingdom in respect of Northern Ireland, in implementing these measures shall be eligible for assistance from the Fund up to a maximum of:

- 3,2 million ECU for the measures referred to in Article 3 (1) (a) and (b),
- 37,5 million ECU for the measures referred to in Article 3 (1) (c),
- 27,0 million ECU for the measures referred to in Article 3 (1) (d),
- 7,6 million ECU for the measures referred to in Article 3 (1) (e),

However, if it proves necessary at a later stage, the Commission may at the request of one of the Member States concerned adjust the above maximum amounts under the procedure referred to in Article 3 (2), provided the total amount of eligible expenditure does not exceed

75,3 million ECU".

2. In Article 5 (1), "27.5 million ECU" is replaced by "37,5 million ECU".

Article 2

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

EXPLANATORY MEMORANDUM

1. As a result of the extremely unfavourable climate in Greece conditions for agricultural production are particularly difficult ; hence the fact from adequate agricultural incomes, on which a large number of the working population in the regions concerned depend.

In an attempt to alleviate this situation the development of irrigation must be encouraged. But at the same time, the anticipated improvement in productivity must be geared to market requirements.

2. At its meeting on 16 and 17 May 1983 the Council called on the Commission to submit a prompt proposal for a Community measure for the launching of an agricultural irrigation programme in Greece similar to that already in operation in the Mezzogiorno under Regulation (EEC) N° 1362/78. The Community's total contribution towards this measure and towards the development of agricultural advisory services was set by the Council at 12 million ECU.
3. The Community's contribution to the proposed measure is to be covered by the five-year endowment of the EAGGF Guidance Section.

Whereas the development of irrigation in Greece is therefore of particular
interest to the Community ; whereas the measures associated therewith
consequently constitute a common measure within the meaning of Article 6 of
Council Regulation (EEC) N° 729/70 of 21 April 1970 on the financing of the
common agricultural policy (3),

HAS ADOPTED THIS REGULATION :

Article 1

A common measure within the meaning of Article 6(1) of Regulation (EEC) N° 729/70 is hereby introduced, to be implemented by Greece, for the purpose of developing irrigation in that Member State.

Article 2

The Commission may grant aid for the common measure from the European Agricultural Guidance and Guarantee Fund, Guidance Section, to finance one or several special irrigation programmes.

Article 3

1. The special irrigation programmes referred to in Article 2 shall involve collective irrigation works using existing resources, including associated drainage.
2. The special programme must :
 - (a) promote improved orientation of production to market requirements ;
 - (b) indicate the number of hectares in the irrigation area or areas to be provided with irrigation networks, including associated drainage, and their location ;
 - (c) indicate the plans and schedule for the public works required in connection with the special programme ;
 - (d) indicate the average cost per hectare of agricultural area referred to in (b) and the estimated total cost of the special programme.

Article 4

1. Applications for aid from the Fund for special programmes must be submitted through the Greek Government.
2. Applications for aid from the Fund must be accompanied by information making it possible to establish that the special programme satisfies the requirements laid down in Article 3.

3. The particulars which must be given in the applications and the form in which they must be presented shall be determined in accordance with the procedure laid down in Article 15 of Council Regulation (EEC) No 1362/78 (4), after the Fund Committee has been consulted on the financial aspects.

Article 5

1. Aid from the Fund shall consist of capital grants, paid in a lump sum or in instalments.
2. Aid from the Fund shall be 50% of the cost of implementing the hydraulic public works which have not yet started, within the limits of the cost incurred per hectare irrigated up to a maximum of 5.000 ECU.
3. The Commission shall, after consulting the Fund Committee on the financial aspects, decide upon aid from the Fund in accordance with the procedure laid down in Article 15 of Regulation (EEC) No 1362/78.
4. The Greek Government and the public authority responsible for implementation of the special programme shall be notified of the Commission's decision.

Article 6

1. The duration of the common measure shall be limited to one year with effect from 1 January 1984.
2. The estimated cost of the common measure to the Fund shall be 8 million ECU.

Article 7

1. Advances may be granted by the Fund on the basis of the part of the public works referred to in Article 3(2) (c) to be carried out under a special programme in one year.
2. The advances may not exceed 80% of the Community contribution to the estimated yearly cost of the public works referred to in paragraph 1.

3. Detailed rules for the application of this Article shall be adopted in accordance with the procedure laid down in Article 13 of Regulation (EEC) N° 729/70.

Article 8

The provisions of Articles 13 and 14 of Regulation (EEC) N° 1362/78 shall apply in a corresponding manner to this common measure.

Article 9

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

EXPLANATORY MEMORANDUM

The implementation of the structural measures in Italy, and in particular some of the provisions of Council Regulation (EEC) N° 1944/81 of 30 June 1981 establishing a common measure for the adaptation and modernization of the structure of production of beef and veal sheepmeat and goatmeat in Italy, is currently being hampered by a cash shortage on the farms concerned, resulting from a temporary excessive debt burden caused by short-term operating loans.

A measure aimed at assisting these farms, by transforming their short-term loans into medium-term loans, could remove the obstacles to application not only of the measure provided for by Regulation (EEC) N° 1944/81 but also of other structural measures, in particular those provided for in the socio-structural Directives, in regions other than those referred to in the above-mentioned Regulation.

At its meeting on 16 and 17 May, the Council therefore requested the Commission to put forward a proposal to that end.

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,
and in particular Article 43 thereof,

Having regard to the proposal from the Commission (1),

Having regard to the opinion of the European Parliament (2),

Whereas difficulties concerning, in particular, the cash flow position of agricultural holdings are jeopardizing the effective application of the structural measures in Italy, and in particular those provided for in Council Regulation (EEC) N° 1944/81 of June 1981 establishing a common measure for the adaptation and modernization of the structure of production of beef and veal, sheepmeat and goatmeat in Italy (3);

Whereas a special emergency measure to relieve the debt burden of livestock holdings by transforming short-term loans into medium-term loans may assist the launching of the above-mentioned structural measures;

Whereas the same difficulties also exist in regions of Italy other than those referred to in Regulation (EEC) N° 1944/81;

Whereas the special system of operating loans applicable in Italy makes it necessary for the conditions of the measure to be laid down by that Member State,

HAS ADOPTED THIS REGULATION :

Article 1

1. In order to facilitate the launching of the measures provided for in Regulation (EEC) N° 1944/81, a special emergency measure to assist agricultural holdings eligible for the measures provided for in the said Regulation is hereby established.
2. The measure may be extended to livestock holdings situated in other Italian regions than those referred to in Regulation (EEC) N° 1944/81.

Article 2

The measure shall consist in the granting of an interest-rate subsidy for the transformation of short-term loans, the duration of which does not exceed 12 months, taken up by the holdings referred to in Article 1 before 30 November 1983 to cover their operating costs, into medium-term loans.

Article 3

Italy shall adopt the provisions necessary for the implementation of the measure, in particular as regards the amount and the duration of the interest-rate subsidy referred to in Article 2 within two months of the entry into force of this Regulation.

Italy shall notify such provisions forthwith to the Commission.

Article 4

1. The Community's contribution to the financing of the measure within the limits of the appropriations entered in the Community's general budget for that purpose. The Community's contribution to the financing is estimated at 60 million ECU and shall be decided on in accordance with Article 7(1) of Regulation (EEC) No 729/70.
2. The provisions of Articles 8 and 9 of Regulation (EEC) N° 729/70 shall apply to the measure.
3. Advances may be granted on application by Italy.

4. Detailed rules for the application of this Article shall be adopted in accordance with the procedure laid down in Article 13 of Regulation (EEC) N° 729/70.

Article 5

This Regulation shall enter into force on the third day following its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
