

EXPLANATORY NOTE

Directive 64/432/EEC on animal health problems affecting intra-Community trade in bovine animals and swine and Directive 80/217/EEC establishing Community measures for classical swine fever control, refer in their annexes to responsible national laboratories and to the title of official veterinarian responsible for issuing health certificates.

Consequently, these texts must be modified to take account of the accession of Greece.

Proposal for
COUNCIL DIRECTIVE

amending Directives 64/432/EEC on animal health problems affecting intra-Community trade in bovine animals and swine and 80/217/EEC establishing Community measures for classical swine fever control, as a result of the accession of Greece

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to the Act of Accession of Greece, and in particular Article 146 thereof,

Having regard to the proposal from the Commission,

Whereas, pursuant to Article 22 of the Act of Accession, the adaptations to the instruments listed in Annex II to the said Act are to be drawn up in conformity with the guidelines set out in that Annex;

Whereas Directive 80/217/EEC, which was adopted after the signing of the Treaty of Accession and which is valid after 1 January 1981, should be adapted to ensure compliance with the provisions of the Act of Accession;

HAS ADOPTED THIS DIRECTIVE:

Article 1

Directive 64/432/EEC as last amended by Directive 80/219/EEC, is hereby amended as follows:

1. In Annex B, point 12, the following is added:

"J) Greece: Κτηνιατρικόν 'Ινστιτούτον Λοιμωδῶν καὶ Παρασιτικῶν Νοσημάτων, 'Ιερά ὁδός, 75 'Αθῆνας 301".

2. In Annex C, point 9, the following is added:

"J) Greece: Κτηνιατρικόν 'Ινστιτούτον Λοιμωδῶν καὶ Παρασιτικῶν Νοσημάτων, 'Ιερά ὁδός, 75 'Αθῆνας 301".

3. In Annex F, the following is added to footnote 4 of model certificate I and footnote 5 of model certificates II, III, and IV:

"In Greece : Ο Προϊστάμενος της Κτηνιατρικής 'Υπηρεσίας του σημείου έξοδου".

Article 2

To the list of national laboratories for swine fever set out in Annex II to Directive 80/217/EEC is added the following:

"Greece : Κτηνιατρικόν 'Ινστιτούτον Λοιμωδῶν καὶ Παρασιτικῶν Νοσημάτων ('Εργαστήριον ζολογίας) Νεαπόλεως, 9 'Αγία Παρασκευή 'Αττικῆς".

Article 3

The Member States shall bring into force the laws, regulations and administrative provisions necessary to comply with this Directive, in respect of Article 1, not later than 1 January 1981, and in respect of Article 2, not later than 1 July 1981. They shall forthwith inform the Commission thereof.

Article 4

This Directive is addressed to the Member States.
