**DRAFT AMENDING BUDGET No 1  
TO THE GENERAL BUDGET 2025**

**ENTERING THE SURPLUS OF THE FINANCIAL YEAR 2024**

Having regard to:

- the Treaty on the Functioning of the European Union, and in particular Article 314 thereof, in conjunction with the Treaty establishing the European Atomic Energy Community, and in particular Article 106a thereof,
- Council Decision (EU, Euratom) 2020/2053 of 14 December 2020 on the system of own resources of the European Union<sup>1</sup>, entered into force on 1 June 2021,
- Regulation (EU, Euratom) 2024/2509 of the European Parliament and of the Council of 23 September 2024 on the financial rules applicable to the general budget of the Union (recast)<sup>2</sup>, and in particular Article 44 thereof,
- the general budget of the European Union for the financial year 2025, as adopted on 27 November 2024<sup>3</sup>,

The European Commission hereby presents to the European Parliament and to the Council the draft amending budget No 1 to the 2025 budget.

## EXPLANATORY MEMORANDUM

Draft Amending Budget (DAB) No 1/2025 is intended to enter in the 2025 budget the surplus resulting from the implementation of the financial year 2024. As provided for in Article 18(3) of the Financial Regulation applicable to the general budget of the Union<sup>4</sup> (“Financial Regulation”), the balance from 2024 is the only subject of this DAB and it has to be submitted within 15 days of the submission of the provisional accounts at the end of March 2025.

1. The implementation of the budget year 2024 shows a surplus of about EUR 1.3 billion, which is therefore entered as revenue in the 2025 budget.

2. Budgeting the surplus will reduce the total contribution of the Member States to the financing of the 2025 budget accordingly. The contributions by Member States will also be influenced by the revised own resources forecast, which will be available after the meeting of the Advisory Committee on Own Resources later in 2025 and which will be included in a subsequent Draft Amending Budget in accordance with Article 44(1)(b) of the Financial Regulation.

4. The combined net variations in Title 1 (*Own Resources*) and Title 2 (*Surpluses, balances and adjustments*) total minus EUR 86.9 million. This small negative difference is predominantly driven by exchange rate differences when cashing the own resources. The outturn of customs duties was very close (99.7 %) to the updated forecast included in amending budget 4/2024<sup>5</sup>.
5. The variations in Title 4 (*Financial revenue, default interest and fines*) amount to EUR 1 210,7 million, which comprises revenue from competition fines and default interest, other penalty

The overall amount for Title 4 includes amounts that have been entered as negative revenue into the 2024 budget in accordance with Article 48(2), point (b) of the Financial Regulation, for a total of EUR 534,4 million. This covers the payments made under settlement agreements concluded and paid in 2024, as standard-rate compensatory interest and default interest compensations due to seven undertakings, in accordance with the judgment of the Court of 11 June 2024 in Case C-221/22 P *Deutsche Telekom v Commission*, relative to the repayment of competition fines annulled or reduced by the Union Courts, as set out in the table below:

7. The amount of voted budget appropriations not implemented by all institutions combined was EUR 272,5 million. The Commission implemented 99.98 % of the authorised payment appropriations (including carry-overs to 2025). The underimplementation of the Commission concerned an amount of EUR 34,4 million of voted appropriations, as well as EUR 96,2 million of appropriations carried over from previous years.
8. Similarly the under-implementation and the cancellation of appropriations of the other institutions remained low in 2024.
